# Shortage of ADHD Medicines; Who's Paying Attention? Colleen Copelan, M.D.



Those of us who treat children are accustomed to calls from parents and teachers, family therapists and even probation, but 2011 was the

year of calls from pharmacies.

Or from parents who could not find a pharmacy to their prescription for any stimulant ADHD medicine, at the right dose or at all.

ADHD medicine shortages sent parents scrambling, phones ringing and homework plummeting all across America.

Actually, significant drug shortages made the news in nearly all areas of medicine last year, prompting President Obama to issue an executive order in November for the FDA to get on top of this chronic and recurrently severe problem.

Shortages often develop without warning, due to manufacturing difficulties or simply marketing decisions. There's no central monitoring of supply and little in the way of reporting required by the FDA.

And add to this, the fed's worry-

-and distraction--with diversion of ingredients for ADHD medicines. The Drug Enforcement Administration's cap on the production of ingredients has contributed to the shortage.

That dilemma is captured in a December article in the New York Times: "We have reached out to the D.E.A. and told them that there are shortage issues," said Valerie Jensen, associate director of the F.D.A.'s drug shortage program. "But the quota issues are outside of our area of responsibility."



# Council Highlights December 8, 2012

Dr. Schaepper called the meeting to order. November minutes were reviewed, and a motion was made to accept the minutes. All voted in favor; none opposed. Dr. Lymberis discussed the Psychiatric Education and Research's second annual fundraiser: "Beethoven: Creative Genius and Psychiatric Illness. Performance and Talk by Richard Kogan, M.D," which will be held 4/14/2012. Register at <a href="www.perfoundation.org">www.perfoundation.org</a> or email <a href="mailto:MGlazerPER-Coord@aol.com">MGlazerPER-Coord@aol.com</a>, where discount registration is available. The closing of Cedars-Sinai Psychiatry Department was discussed. Dr. Schaepper discussed graduate medical education funding. Dr. Thurston discussed general funding of MediCal. A website committee re-

port was given by Dr. Red. The Council discussed issues related to Blue Cross and other insurance companies. The Council discussed changing the January Council meeting to Tuesday, 1/3/12 in order to host a forum for the candidates for APA President. A motion was made to continue with Council meeting as scheduled on 1/12/11. All voted in favor, and none opposed. A motion was made for any CPA or APA candidate may attend the January or February SCPS council meeting. All voted in favor, and none opposed. Dr. Lawrence read the nominations for the 2012 council positions, and a motion was made to accept these nominations. All voted in favor, and none opposed. A motion was made for the Council to authorize the nominating committee to approve any vacancies not reported as a part of the previous nominations. All voted in favor, none opposed. Dr. Ettekal gave the treasurer's report. In November, the SCPS was charged a four year pass-thru fee as a part of their lease, which significantly impacted the November budget. Dr. Ettekal reported on financial planning for the SCPS. After discussion, the motion was tabled until the January meeting. A motion was made to accept the treasurer's report; all voted in favor, and none opposed. The membership committee did not have any items to report. Ms. Thelen reported on the Psychopharmacology Update on 1/28/12 as a part of the program committee. For more information and registration, visit www.solcalpsych.org. Dr. Thurston gave the legislative report. As new business, Dr. Schaepper discussed the cessation of AB3632 funding and asked that any relevant cases be reported. Also, the location of future Council meetings was discussed. Next month's Council meeting will be at The Life Adjustment Team conference room. A discussion regarding legalizing marijuana concluded the Council meeting. This item will also be put on the agenda for next month's Council meeting. Dr. Schaepper adjourned the meeting.
